- 1. Does water in the current HVAC Heat Pump Piping system have Glycol in it?
 - a. If this refers to the load side of the heat pump serving the equipment, the load side of the heat pump system does not contain glycol.
- 2. Does the water in the Geothermal piping system have Glycol in it?
 - Yes, the current heat pump ground source fluid is 15% Propylene Glycol mixer. See Mechanical drawings provided page MH602 Heat Pump Schedule. (Issued in Amendment 0004)
- 3. If it is determined that there is no glycol or other substance either system, would the VA want it in the new system?
 - (Glycol in system prevents freezing of the system water, provides corrosion resistance for the piping, improves the heat transfer in the system, etc.)
 - a. As there is no glycol in the current load side of the existing system no glycol is required. The source side shall contain a glycol mixture as recommended by the manufacturer of the equipment that will be replacing the existing Multi Stack Heat Pump.
- 4. Please confirm that the VA wants the water in the geothermal system flushed and cleaned as part of the contract.
 - a. Safely remove and dispose of existing ground loop water contents and replace with newly treated water/glycol mixture as per manufacturer recommendations. Prior to final fill of new ground source water/glycol mixer, flush ground source loop.
- 5. Please confirm that it is the intent of the VA to replace all the heat pumps in current Multi-Stack heat pump system and replace with an all new system.
 - a. The intent is to remove the current Multi Stack system and replace with new equivalent combined heating and cooling system while taking advantage of the existing ground source water geothermal field. This new equivalent system can be the same general technology as the current multi-stack system or a completely different technology.
- 6. can VA provide the any measurement data, operational issues, capacity etc of the geothermal well.

- a. See geothermal balancing report of the water pumps and wells attachment.
- a. In 2017 there was a suspected leak in loop 4 but has been repaired and back in service.
- 7. Provide the list of any known issue with geothermal well.
 - a. See Multi Stack Issues log page 1 and page 2 (attached), see Trane service visits field reports (Issued in Amendment 0004).
- 8. Confirm if there are any modifications to be made with all pumps and associated piping.
 - a. Existing pumps and piping shall remain unless new equipment design requires larger capacities.
- 9. Confirm if there is adequate power available for the replacement unit.
 - a. Unable to provide accurate response as replacement equipment has not been determined.
- 10. Confirm if there are any other modifications to be done besides the replacement of unit.
 - a. There are no additional modifications determined at this time.
- 11. Does VA requires to replace the unit made by existing unit manufacturer or acceptable by other manufacturers?
 - a. The replacement heating and cooling system does not need to match existing manufacturer. Other manufactures will be permitted.
- 12. Can the VA Provide list of other preferred manufacturers.
 - a. The VA will rely on the awarded design build team to present options of different manufacturers and different new methods or technologies utilizing geothermal condensing water.
